2024 Symposium

A big thanks to everyone who attended the **2024 Symposium** which was held on **Saturday**, **June 29th** at the Oak Harbor High School. We heard from industry and agency representatives on various topics including Reservoir Inspections, Remote Read Meters, Remote Metering Pumps and the DW State Revolving Fund. Another big thanks to all of our participants who presented and/or created and managed the displays as well as our panel members.

The closing panel session was quite lively with lots of questions and discussion regarding how to keep our water systems functioning, including how to obtain service for preventive maintenance and failures (especially electricians which seem to be in short supply), how to go about determining the amount of reserve funds needed for future equipment and piping replacements, how long equipment and piping typically lasts and more. The issue of aging infrastructure was a big concern among the attendees.

News from our Partners

Island County

• In July the county issued a Request For Proposal (RFP) soliciting proposals from firms to update the Coordinated Water System Plan (CWSP). If you aren't familiar with the CWSP, it acts as a regional supplement to each individual water system plan, and includes guidance for those water systems, including minimum design standards. For more information, the county has provided this summary in which you'll note that "All water purveyors within the CWSSA shall be notified and asked to participate in the development and update of the CWSP". Department of Ecology

• Earlier this month, the Department of Ecology issued a <u>Washington Water Supply Update</u> which continued the drought declaration already in effect and provided a summary and links to the recent <u>Water Supply Availability Committee</u> (WSAC) meetings. The release noted that there is some hope for a wetter fall but "Averaged statewide, the water year so far (October through June) was the 15th warmest and 50th driest on record."

Department of Health/Office of Drinking Water

 The latest <u>ODW Newsletter</u> includes information on the Lead Service Line inventory, CyberSecurity, SWAP Map updates and more. The next Quarterly Drinking Water Advisory Group (DWAG) meeting is scheduled for September
